(9) This Interim Waiver and Release Upon Payment constitutes a representation by the undersigned, for and on behalf of the Subcontractor/Supplier, that the payment referenced above, once received, constitutes full and complete payment for all work performed, and all costs or expenses incurred (including, but not limited to, costs for supervision, field office overhead, home office overhead, interest on capital, profit, and general conditions costs) relative to the work or improvements at the Property as of the date of this Interim Waiver and Release Upon Payment. The Subcontractor/Supplier hereby specifically waives, quitclaims and releases any claim for damages due to delay, hindrance, interference, acceleration, inefficiencies or extra work, or any other claim of any kind it may have against the General Contractor, the Owner, the Tenant, or any other person or entity with a legal or equitable interest in the Property, as of the date of this Interim Waiver and Release Upon Payment.
